- Our second big show of 2018 goes up at the Aspen Surgery Center in John Muir Hospital in Walnut Creek in just a week. The take-in for the show will be from 10am to 11am at the Presbyterian Church on Park Boulevard next Friday March 2nd. The updated rule sheet is attached with all the details, but be aware of some very specific rules for this show:
 - o Frames containing glass are not allowed must be plastic.
 - o Minimum size including the frame is 17 x 21".
 - o Maximum size including the frame is 42"x 46"
 - The price of each piece of art must be priced under \$1500
- The next Chamber show goes up on Friday March 16th, bring your work to the Presbyterian Church on Park Blvd. between 10 am and 11am. Ross Drago will be our judge the updated rule sheet is attached.
- Remember too that our annual photo show is planned for the Law Library on Thursday March 29th, rules with all the details will follow in the next email. Since this show is only up for a month, the entry fees will be reduced to only \$4 per entry.
- The OAA Board approved our 2018 budget during their last meeting, it's attached for your information.
- Also, during the last Board meeting it was decided to drop the printed newsletters delivered by mail in favor of these email communications. The once a month printed newsletters cost almost \$1000 per year and took a lot of work to publish. These more frequent emails have proven to be a lot more effective in delivering "just the facts" on a timely basis.
