## Tina Nelson Always reaching for the next level

My husband Rick and I recently returned from a photographic trip to Mexico where we learned a lot about the culture, traditions, the personality of the Mexican people and also learned about taking better pictures. We did get some great photos hopefully many of which are inspirations for my paintings.

I had my first art class when I was in college, got hooked, graduated with an Art degree, and went on to teach art in both Montana and California. mostly worked in oils and pencil at this time, but then by the time our daughters were born I started working in ceramics and selling at local fairs. We ultimately built several our own potters wheels and kilns, involving the whole family including the girls!

By the time the kids were in High

School I decided to go back to school at San Jose State to earn a masters degree in Art. During those few years I mostly studied printmaking, etchings and monotypes, while at the same time teaching classes at the San Jose Museum.

With the girls off to college and Rick working in Oakland and Walnut Creek, we decided to move from our long time home in to Newark Walnut Creek. About this time I took some additional classes in watercolor. which I found to be much freer than the etching process I had been concentrating on for the past several years. After arriving in Walnut Creek we built a studio next to our home and I began teaching again on a regular basis, learning more than I taught. I continued in watercolor and with the advent of the digital camera and "Photoshop" Rick and I both began taking a serious interest in photographs as well.

I stopped teaching about five years ago to free up more time for my painting and photography.

Over the past two years have been working with Pastels, and like the direct application, the quick deliberate strokes I didn't seem to be able to get with oils and watercolor. I don't think I could stop painting, though it very challenging - it's a "love relationhate" ship for me, I'm always challenging myself.

## Shari Arai DeBoer Judges January Chamber Show



JUROR: Susan Tuttle (co-Director of the Montclair Gallery)

ACCEPTED WORKS: Pick up at the Presbyterian Church on Friday March 16th,2007 between 10 AM and 12 noon.

#### ENTRIES:

• Entries will be two dimensional; 16"x 20" minimum and 36"x 36" maximum.

- Up to 3 entries accepted per member, but only 1 of the 3 may be "large" (i.e. over 30").
- Works restricted to original work no class work or copies.
- Nudes and political statements are not accepted (venue requirement).
- All work must be for sale.
- Up to three works may be submitted; three may be accepted.
- The Chamber reserves the right to reject any work from the show for any reason.
- Any work shown at a Chamber of Commerce Show prior to 2004 may be shown again at this show.
   Any work having won a cash award in any OAA show is not eligible to receive another cash award but may receive a merit award.
- To be entered as a single work, any grouping of 2 or more works must be mounted within a single frame which meets the overall size requirements.

ENTRY FEE: \$8.00 per entry.

#### **FRAMING:**

- No wide (may not exceed 3") or elaborate frames will be accepted.
- Mats must be clean and well cut.
- Frames must be clean, sturdy and no protruding screw eyes or hangers will be allowed.
- Works larger than 24" x 30" (if covered) must be under plastic instead of glass.

<u>LABELS:</u> Must be filled out completely and affixed to the upper left hand corner on the back of the entry.

PLEASE TYPE OR PRINT LEGIBLY!

**AWARDS:** First award \$100; Second award \$50; Third award \$25. Merit awards are given at the discretion of the Juror.

**INSURANCE:** A signed waiver must be on file with the Membership Chairman or be filled out and signed on receiving day.

#### SALES:

- All sales made during the show and/or 30days following the close of the show (if the work was seen by the buyer at the show) will be handled by the Treasurer (Stan Cohen 510 553-3003).
- OAA policy is that no change will be made in the price (in connection with this show) after the work is accepted.
- The artist agrees that 30% of the sale price will be taken as a contribution to OAA.
- Sales tax of 8.75% will be added to all sales.
